The Board is pleased to announce that all the resolutions proposed were duly passed by way of poll at the AGM held on 27 August 2020.

The board (“**Board**”) of directors (the “**Directors**”) of Huabang Financial Holdings Limited (the “**Company**”) is pleased to announce that all the resolutions proposed were duly passed by way of poll at the annual general meeting of the Company held on 27 August 2020 (the “**AGM**”).

As at the date of the AGM, the total number of ordinary shares of the Company in issue (the “**Shares**”) was 4,384,782,000, being all the Shares which entitled the shareholders to attend and vote for or against all the resolutions proposed at the AGM. To the best of the Directors’ knowledge, belief and information, no shareholders had a material interest in the resolutions proposed at the AGM. None of the shareholders were required to abstain from voting at the AGM under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).
